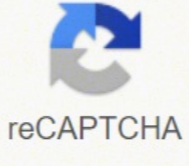

History The company was formed in 1945 as the Industrial and Commercial Finance Corporation (ICFC), by the Bank of England and leading British banks to provide long-term investment finance for small and medium-sized businesses. ^ "3i group". [11] In July 1999, Kingfisher attempted to acquire ASDA, one of the UK's largest supermarket chains, only to be beaten by Walmart. [12] In August 2001, along with an acrimonious battle for control of Castorama, [13] The resulting stock price pressure forced the sale and demerger of several parts of the company, including Woolworths (forming the Woolworths group), [14] and the demerger of The Elective Business, to form KESA electrics in July 2003 - causing the company to refocus entirely around DIY. [15] The company was led by Gerry Murphy from December 2002 to November 2007. [16] In January 2008, Kingfisher appointed Ian Cheshire as the group's chief executive. [16] Cheshire was the CEO of B & Q; His B & Q role was taken over in April 2009 by Euan Sutherland, who also headed Kingfisher's UK division.
